# 14:30 – 15:45 THE GIGABIT RECOMMENDATION: NEARING THE END-GAME FOR SMP REGULATION?

The draft Gigabit Recommendation foresees light touch regulation for fibre in cases where there are sufficient constraints from infrastructure competition and/or anchor products. It also seeks to accelerate the process for copper switch-off. In this session, we hear from the future Chair of BEREC and leading industry representatives about the future role of SMP regulation in telecoms in an environment increasingly characterised by wholesale only infrastructure companies and commercial deals, whether the draft Recommendation strikes the right balance between investment and competition as we head into an environment where FTTH networks dominate, and consider what impact it may have on NRA's market analyses going forward.

#### 15:45 – 17:00 KEYNOTE DEBATE: TELECOMS MARKETS IN 2030

In this session, through insights from academics, industrial leaders, MVNOs, cloud providers, infrastructure companies and telcos, we will explore how the telecoms value chain is evolving, and the role that different players could take. Will telecom operators will become "infrastructure as a service" or solution providers, or will the trend towards towercos, netcos and the cloudification of telecoms networks, alongside industry deploying its own private 5G networks leave telcos searching for a role? What stake will online platforms and application providers have in the new ecosystem? Will some networks (e.g. for industrial sites) become more localised, while others need to adapt to cross-border needs e.g. for loT? What will be the implications for competition and consumer welfare? Should there be an expanded role for roaming regulation and/or cross-border spectrum assignment? What implications might these developments have on regulations regarding access and interoperability? Will the recently transposed EU electronic communications Code provide the tools needed if and where barriers arise? We will analyse the different scenarios that could emerge and explore the implications for competition and the future regulation of the sector.
